ORDER APPROVING ADMINISTRATRIX'S FINAL  
REPORT AND ACCOUNTING,  
PETITION TO ALLOW ACCOUNTING, PETITION  
TO DETERMINE HEIRSHIP, AND PETITION FOR  
ORDER APPROVING DISTRIBUTION AND  
CLOSING ESTATE

This cause came to be heard on this *31st* day of December,  
1981, upon the final account, petition to settle and allow account and  
for authority to distribute estate filed by Elizabeth Myrick, Successor  
Administratrix of the estate of Alvin H. Porter, deceased, which  
account and petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and  
the Court being fully advised in the premises now finds that:

1. The notices of the filing of said account and petition of  
the hearing on the same were given to all persons interested in said  
estate and the same are now properly before the Court for final  
action thereon.
2. That all interested persons executed a waiver and consent  
to accept successor administratrix's final account, petition to settle  
and allow accounting, petition for authority to distribute assets remaining  
and close estate.
3. That Alvin H. Porter, died testate, a resident of the  
County of Lake, State of Indiana, on the 8th day of June, 1977, and  
his Last Will and Testament was duly admitted to probate before this  
Court on the 8th day of August, 1978, and this Court appointed said  
Cozetta Porter, executor of the Last Will and Testament of the  
decedent and said executor was issued Letters of Testamentary on  
the 8th day of August, 1978 and since that date continued to serve  
until on or about the 3rd day of March, 1980. That Elizabeth Myrick,  
was duly appointed by this court as successor administratrix, qualified  
on the 15th day of March, 1981 and since that date she has continued  
to serve in such capacity.
4. That the matters and things stated in said account and  
petition are true, and that said administratrix has accounted for all  
the assets in said estate coming into her hands.
5. That more than five (5) months have elapsed since the  
date of first published notice to legatees, devisees and creditors of  
said decedent; all claims filed against said have been paid and discharged;  
neither said decedent nor his executor nor his successor administratrix  
were employers of labor within the meaning of that term as used in

the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5 The following persons are the sole legatees and devisees under the decedent's Last Will and Testament: Alveretta Payne, Elizabeth Myrick, Cora Harris, Delores Johnson, Harriett Dogan and Thelma Humphrey each one-sixth (1/6) interest, share and share alike, and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration has been distributed to the above named persons.

6. That the decedent owned no real estate at the time of his death other than a piece of real estate located at 2367 Ohio Street, Gary, Indiana, legally described as:

Lot 24, and the North 10 feet of Lot 23, Block 32, Ironwood Unit "A" Subdivision in the City of Gary, as per plat thereof recorded in Plat Book 21, page 4, in the Office of the Recorder of Lake County, Indiana \* \* \* \* \*

and that the decedent devised said real estate in Article III of his Last Will and Testament and a life estate interest to Cozetta Porter, who died on the 3rd day of March, 1980. That a copy of this decree showing the vesting of said real estate should be recorded in the Office of the Lake County Recorder.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said successor administratrix is hereby in all things approved, settled and confirmed.
2. That the distribution of the balance of the property remaining in said administratrix's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.
3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:

Lot 24, and the North 10 feet of Lot 23, Block 32, Ironwood Unit "A" Subdivision in the City of Gary, as per plat thereof recorded in Plat Book 21, page 4, in the Office of the Recorder of Lake County, Indiana \* \* \* \* \* is hereby vested in ALVERETTA PAYNE, ELIZABETH MYRICK, CORA HARRIS, DELORES JOHNSON, HARRIETT DOGAN and THELMA HUMPHREY, each one-sixth (1/6) interest, pursuant to the provisions of the decedent's Last Will and Testament.


And that said administratrix is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.

Said administratrix is hereby released and discharged from any further liability or responsibility, along with the surety for the previous executrix, of the estate of Alvin H. Porter, deceased.
