ASSIGNMENT OF REAL ESTATE MORTGAGES

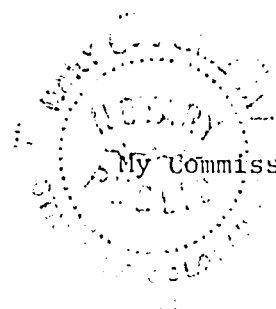
