- Except as herein modified, said note and mortgage shall remain in full force and effect in all respects as if the original sum had originally been payable on August 1, 2006. The covenants of the aforestated recorded mortgage are expressly incorporated by reference herein. The Mortgagors hereby bind themselves, their heirs, successors, executors, administrators, and assigns to perform the covenants and agreements of said recorded mortgage in all respects as now modified.
