WHEREAS, the lien of the United States, ~~XXXXXX~~, for said tax has attached to certain property described as:

WHEREAS, the District Director of Internal Revenue has agreed to the sale of the foregoing property, with the proceeds of such sale to be held as a fund subject to the liens and claims of the United States, in the same manner and with the same priority as such liens and claims had with respect to the said property, and pursuant to this agreement has authorized the issuance, under the provisions of section 6325(b)(3) of the Internal Revenue Code, of a certificate discharging the above-described property from the tax lien of the United States;

NOW, THEREFORE, THIS INSTRUMENT WITNESSETH, That I, Paul D. Williams District Director of Internal Revenue at Indianapolis, charged by law with the duty of collecting and enforcing the collection of internal revenue taxes due to the United States, and charged with the assessment hereinbefore stated, do, pursuant to the provisions of section 6325(b)(3) of the Internal Revenue Code, discharge the property heretofore described from the aforesaid tax lien, saving and reserving, however, the force and effect of said tax lien against and upon all other property or rights to property to which said lien is attached, wheresoever situated.
