1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That HENRY TURNER died testate, a resident of the County of Lake, State of Indiana, on the 8th day of September 1981, and his Last Will and Testament was duly admitted to probate before this Court on the 18th day of September, 1981 and this Court appointed said PHILLIP TURNER as executor of the Last Will and Testament of the decedent, and said executor issued Letters Testamentary on the 18th day of September, 1981 and since that date he has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said executor has accounted for all the assets in said estate coming into his hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his executor were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.
