The Executor shall not be held liable in any manner or in any amount whatever for filing or failing to file such a consent.

The foregoing powers granted to my Executor in Paragraphs

A. B and C of this Item of my Last Will and Testament shall be in

addition to any conferred upon the court either prior to or after the exercise of any such power.
