
And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

- That the distribution of the balance of the property remaining in said coexecutors hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last will and Testament of said decedent and is hereby in all things approved.
- 3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wir:
