A RESOLUTION VACATING THE ALLEY FROM
MAITLAND STREET TO MONTGOMERY STREET
SOUTH OF 37th AVENUE

WHEREAS, the Board of Public Works and Safety of the City of Hobart, Lake County, Indiana, desires to vacate an alley or portion thereof which is particularly described below; and

WHEREAS, the Plan Commission of the City of Hobart on May 11, 1976, in Plan Commission Action No. 76-12 approved such vacation; and

WHEREAS, the Board of Public Works and Safety of the City of Hobart now determines that it would be in the best interest of the City of Hobart that such alley be vacated.

NOW, THEREFORE, be it resolved by the Board of Public Works and Safety of the City of Hobart, Lake County, Indiana, that the following described alley within the city of Hobart, Indiana, shall be and is hereby vacated:

"The alley 125 feet south of 37th Avenue running West to East from Maitland Street to Montgomery Street and situated adjacent to Lots 1 thru 7 and Lot 30, Block Ridgwood Addition to Gary in the City of Hobart, Lake County, Indiana."

Provided, however, that the City of Hobart and any and all public utility companies retain the right to maintain, operate, repair and replace by themselves or by any licensee any poles, wires, pipes, conduits, sewer mains, water mains or any other facility or equipment for the maintenance or operation of any utility now located in the alley or portion thereof vacated by this Resolution.
