A parcel of land in the East Half (E½) of the Southeast Quarter (SE¼) of Section Twenty-Four (24), Township Thirty-Three (33) North, Range Eight (8) West of the Second Principal Meridian, in Lake County, Indiana, described as follows: Commencing at the Southeast corner of said Section Twenty-Four, thence West along the South line of said Section Twenty-Four a distance of 1,020 feet to a point which is the place of beginning; thence continuing along the said South line of said Section Twenty-Four a distance of 200 feet to a point; thence North along a line parallel to the East line of said Section Twenty-Four a distance of 240 feet to a point; thence East along a line parallel to the South line of said Section Twenty-Four a distance of 200 feet to a point; thence South along a line parallel to the East line of said Section Twenty-Four a distance of 240 feet to the place of beginning.

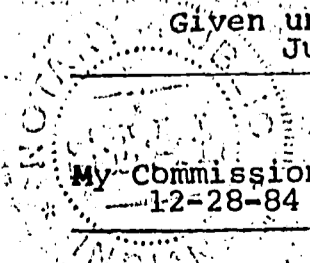
