ASSIGNMENT OF REAL ESTATE MORTGAGES

TO HAVE AND TO HOLD the same unto the said party of the second part, its successors and assigns, forever, subject only to the provisions in the said indentures of mortgage contained.

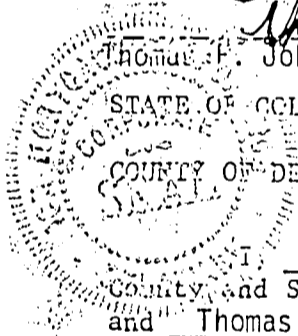

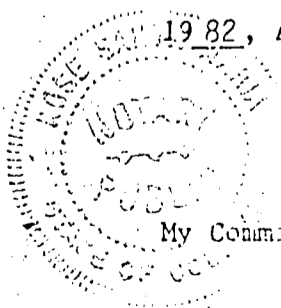
