AND, PROVIDED, the Surety may cancel this bond at any time by giving thirty (30) days notice in writing
mailed to the Obligee.

force and of the number of premiums that shall be payable or paid, the Surety shall not be liable hereunder for a
larger amount, in the aggregate, than the amount of this bond.
