## ASSIGNMENT OF EQUITABLE INTEREST UNDER REAL ESTATE SALE CONTRACT

This Agreement of Assignment made and entered into this of February, 1983, by and between CHARLES WALKER & ESTHER WALKER of Lake County, Indiana (the Walkers) and the FIRST NATIONAL BANK OF EAST CHICAGO, INDIANA (Bank).

AQUINO where in AQUINO has agreed to sell and the WALKERS have agreed to purchase, subject to the terms and conditions contained in said Real Estate Contract, the following described real estate in Lake County, Indiana:

Part of the Northeast Quarter of the Northwest Quarter of Section 12, Towhship 33 North Range 8 West of the 2nd. P.M., more particularly described as follows: Commencing at the Northest Corner of the Northwest quarter of said Section 12, thence South on the East Line of said Northwest quarter of Section 12 a distance of 905.85 feet; thence West parallel the North line of said Section 12 a distance of 577.5 feet; thence North and parallel to the East line of said Northwest quarter of Section 12, a distance of 243.70 feet to the South line of the Northwest quarter of the North half of the East half of the Northwest Quarter of said Section 12 producted; thence West on the South line of the Northwest Part of the Northeast Quarter of the Northwest Quarter of Section 12, Towhship 33 North, Range 8 West of the 2nd. P.M., more particularly described as follows: Commencing at the Norhtest Corner of the Northwest quarter of said Section 12, thence South on the East Line of said Northwest quarter of Section 12 a distance of 905.85 feet; thence West parallel to the North line of said Section 12 a distance of 577.5 feet; thence North and parallel to Quarter of said Section 12 producted; thence West on the South line of the Northwest R Quarter of the North half of the East half of the Northwest quarter produced a distance of 85.95 feet to the Southeast corner of said Northwest quarter of the North half of the East half of the Northwest quarter; thence North on the East line of said Northwest quarter of the North half of the East half of the Northwest quarter a distance of 40.15 feet; thence East parallel to the North line of said Section 12 a distance of 232.20 feet; thence North East parallel to the North line of said Section 12 a distance of 232.20 feet; thence North 622 feet to the North line of Section 12, thence east along said North line 431.25 feet to the point of beginning, in Lake County, Indiana.

NOW THEREFORE, in consideration of credits heretofore granted to Walker by the Bank, and to further secure and collaterlize such indebtedness and any and all future indebtedness of the Walkers, the Walkers hereby assign to the Bank all of their rights, title and interest in and to that certain real estate contract dated the 28th. day of October , 1978 by and between Arlene M. Aquino and CHARLES WALKER AND ESTHER WALKER, including any equity that Walker might have in that real estate described in said Real Estate Sale Contract, provided, however, it is understood and agreed that the Bank, by virtue of accepting the foregoing assignment does not assum any responsiblity of liability to perform any of the obligations

to be performed by the WALKERS under the terms and conditions of said Real Estate Contract.

The Bank agrees that upon the satisfaction of any and all indebtedness of the WALKERS to the Bank, including principal, interest and penalties, if any, that it will release of record this assignment and execute other appropriate documents evidencing the reassignment to CHARLES WALKER & ESTHER WALKER of any interest under said Real Estate Contract.
