
RESCISSION OF ORDER TO COMPLY

1. Tuck point foundation where necessary.
2. Repair windows and frames.
3. Repair siding where necessary.
4. Rebuild rear stairs, treads, risers, stringers and rails.
5. Repair doors and frames.
6. Repair rear roof-sheating, rafters and roofing.
7. Bring electric up to code.
8. Repair entrance to basement-new roof, door and frame, siding, replace rotted sheathing, replace rotted studs and plates.
9. Replace rotted treads or split treads.
