ORDER OF DIRECTOR

FOR AUTHORIZATION FOR THE TRANSFER OF CERTAIN REAL ESTATE TO THE INDIANA DEPARTMENT OF HIGHWAYS, TOLL ROAD DIVISION

WHEREAS, the City of Gary, Indiana has received funding from the Urban Mass Transportation Administration for the construction of a multi-modal transportation center in downtown Gary; and

WHEREAS, as a condition to the receipt of these funds, the City must provide twenty percent (20%) of the total cost of the project, which is called "local share"; and

WHEREAS, the Indiana Department of Highways - Toll Road Division will provide the local share for the City by constructing an interchange on Broadway; and

WHEREAS, in order to construct this interchange, certain City-owned property was conveyed to the Toll Road Division, to-wit; portions of Gateway Park; and

WHEREAS, the conveyance of this land was necessary for the successful completion of the project; and

WHEREAS, pursuant to IC 36-1-11-8, real estate owned by municipalities may be transferred to other governmental entities if both entities adopt substantially similar resolutions; and

WHEREAS, the Common Council of the City of Gary, Indiana, did on or about the 20th day of April, 1982, adopt Resolution Number 1603 whereby portions of Gateway Park was conveyed to the Indiana Department of Highways -Toll Road Division, which said Resolution was recorded on October 19,53982-as Document No. 684509 in the Office of the Recorder of Lake County, Ind and

WHEREAS, The Indiana Department of Highways - Toll Road Division € die on or about the 2nd day of August, 1982, by Order of Director, accept said portions of Gateway Park, which said Order of Director was recorded on October 19, 1982 as Document No. 684509 in the Office of the Recorder of Lake County, Indiana; and

WHEREAS, subsequent to said Resolution and said Order of Director, additional information was received which necessitates the legal descriptions contained in said Resolution and said Order of Director be revised; and
