1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That JESSIE LOUISE SCHWARTZ, died testate, a resident of the County of Lake, State of Indiana, on the 22nd day of June, 1982, and her Last Will and Testament was duly admitted to probate before this Court on the 9th day of July, 1982, and this Court appointed said WENDELL SPITLER as executor of the Last Will and Testament of the decedent, and said executor was issued Letters of Testamentary on the 9th day of July, 1982, to him and since that date he has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said executor has accounted for all the assets in said estate coming into his hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her executor was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said executor is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said executor's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.


3. That pursuant to the decedent's Last Will and Testament the following described real estate, to wit:

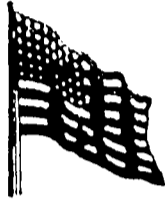
