CONFIRMATORY RESOLUTION NO. 2518

WHEREAS, the Board of Public Works and Safety of the City of Hammond, Lake County, Indiana, did on the 24th day of August, 1978, adopt Declaratory Resolution No. 2518 to vacate a portion of Ames Street, west of Columbia Avenue in Morris' Addition to the City of Hammond, more particularly described as follows:

The sixty feet right-of-way now a part of Ames Street beginning at a point at the Southwest corner of Lot 10, Block 3, Morris Addition to Hammond, thence East a distance of 120 feet to the Southeasterly corner of said Lot 10, thence South 60 feet along the West right-of-way line of Columbia Avenue to the Northeasterly corner of Lot 1, Block 4, Morris Addition to the City of Hammond, thence Westerly 120 feet to the Northwest corner of said Lot 1, thence Northerly and parallel with the West right-of-way line of Columbia Avenue a distance of 60 feet to point of beginning

all as shown by a plat of such proposed vacation now on file in the Office of the Board of Public Works and Safety of the City of Hammond, Indiana; and

WHEREAS, the Board of Public Works and Safety of the City of Hammond, Indiana, after proper legal notice and after public hearing duly held, is now fully advised in the premises;

NOW, THEREFORE, BE IT RESOLVED that said Declaratory Resolution No. 2518 be and it is hereby in all things now CONFIRMED.

BE IT FURTHER RESOLVED, UNDERSTOOD and AGREED that said vacation is made reserving in the vacated portion of said street a right-of-way necessary for the continuation of existing water, drainage, gas, electric, sewer and telephone service or which services may hereafter be granted by the Board of Public Works and Safety upon request of the public utilities or governmental authority desiring to make such installation, and for the maintenance, removal or reconstruction necessarily incidental to said existing or prospective facilities.
