
LAWRENCE - WILLIAM - MURRAY

I, LAWRENCE WILLIAM MURRAY, at this time a resident of the City of Griffith, County of Lake, State of Indiana, and being of sound and disposing mind and memory, do make, declare and publish this instrument to be my Last Will and Testament and do hereby revoke any and all former Wills and Codicils by me made.

In the event any of my children are still minors at this time, I then appoint THOMAS F. MURRAY as guardian of the person and estate of such minor children, with the right to use such funds necessary for the support, education and welfare of said minor children.
