WHEREAS, the undersigned, owners of said premisis, have found it necessary and do hereby request a modification of the terms of said loan for the following reason: to decrease the interest rate of said Adjustable Rate Note, thereby reducing the monthly principal and interest payment, and have paid a Service Charge of ONE HUNDRED SEVENTY FIVE (\$175.00) DOLLARS to CITIZENS FEDERAL SAVINGS AND LOAN ASSOCIATION,

AND WHEREAS, the undersigned do hereby agree to the following modification of certain provisions of said Adjustable Rate Note:

- 1. Under Section 2 entitled INTEREST, paragraph 2, the modifica gen (C shall read as follows: Beginning July 1, 1983, I will pay interest at a yearly rate of 11% (the "Initial Interest Rate"). The interest rate that I will pay will change in accordance with Section 4 of said Note until my loan is paid. Interest rate changes may occur on the first day of each month beginning on July 1, 1984 and on that day of the month every twelve months thereafter.
- 2. Under Section 3 entitled PAYMENTS, subparagraph A, the last sentence of paragraph one, the modification shall read as follows: I will pay all sums that I owe under said Note no later than June 1, 2007 (the "final payment date").
- 3. Under Section 3 entitled PAYMENTS, subparagraph C, the first sentence, the modification shall read as follows: My initial monthly payments will be in the amount of U.S. \$547.19
- Under Section 4 entitled INTEREST RATE CHANGES, subparagraph A, the modification shall read as follows: Any changes in the interest rate will be based on changes in an interest rate index which will be called the "Index". The Index is the: AVERAGE COST OF FUNDS OF THE FHLB OF INDIANAPOLIS DISTRICT SIX. If the Index ceases to be made available by the by the publisher, or by any successor to the publisher, the Note Holder will set the Note interest rate by using a comparable index.
- 5. Under Section 4 entitled INTEREST RATE CHANGES, subparagraph B, the amendment 3 to the ADJUSTABLE RATE NOTE RIDER is hereby deleted and the modification shall be as follows: There will be no maximum limit in changes in the interest rate up or down.
- Under Section 5 entitled BORROWER'S FAILURE TO PAY AS REQUIRED, subparagraph A, the modification shall read as follows: If the Note Holder has not received the full amount of any of my monthly payments by the last business day of each month, I will pay a late chargeto the Note Holder. The amount

of the charge will be 5% of my overdue payment of principal and interest. I will pay this late charge only once in any late payments.
