TOGETHER with the permanent extinguishment of all rights and easements of ingress and egress to, from, and across the limited access facility (to be known as Indiana East-West Toll Road and as Project ITR-10-80(01)) to and from the Owner's remaining lands where they abut the above-described 5.311 acre parcel. ALSO, together with the permanent extinguishment of all rights and easements of ingress and egress to, from, and across the limited access facility (to be known as the Indiana East-West Toll Road and as Project ITR-10-80(01)) to and from the lands abutting the above-described 1.117 acre parcel. ALSO, together with the permanent extinguishment of all rights and easements of ingress and egress to, from, and across a local service road known as Frontage Road Number 2 as constructed on Indiana Department of Highways Project SU-831(9) along the entire West line of the Owner's land; HOWEVER the Owner and his successors in title shall have access rights to said Frontage Road Number 2 where the Owner's remaining land abuts the following described lines: Beginning on the East boundary of said Frontage Road Number 2, Southerly 801.4 feet from the intersection of said East boundary with the North line of said Section 35; thence Southerly 50.00 feet along said East boundary to the terminus; ALSO, a line in Section 26, Township 37 North Range 9 West described as: Beginning on the East boundary of said Frontage Road Number 2, Northerly 598.6 feet from the intersection of said East boundary with the South line of said Section 26; thence Northerly 50.00 feet along said East boundary to the terminus.

The above-described access control line restriction shall be a covenant running with the land and shall be binding on all successors in title to the said abutting lands.

Subject to an easement for the right to operate, maintain, inspect, repair, replace, change the size of and remove pipe lines, in whole or in part (which said pipe lines are now in place and operation), for the transportation of gas, oil, petroleum, or any of its products, water and other substances, which easement was conveyed November 8, 1961, by Cities Service Petroleum Company to Texaco-Cities Service Pipe Line Company by virtue of a Right of Way Grant recorded March 25, 1974, as Document No. 244735, in the Office of the Recorder of Lake County, Indiana.

Also, subject to an easement for the right to lay and maintain trenches and pipe lines for the purpose of conducting gas, which easement was assigned by Indiana Natural Gas & Oil Company to Northern Indiana Public Service Company by virtue of an Assignment of Easement recorded March 27, 1941, in Miscellaneous Record 329, page 98, in the Office of the Recorder of Lake County, Indiana.
