QUIT-CLAIM DEED

THIS INDENTURE WITNESSETH that ALVIN C. MILLER, JR. of Los Angeles County in the State of California, RELEASES AND QUIT CLAIMS TO NORMAN S. SOLOMON of San Diego County in the State of California, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, his undivided one-half interest in the following Real Estate in Lake County in the State of Indiana, to-wit:

Part of the East Half of the West Half of Section 32, Township 37 North, Range 9 West of the Second Principal Meridian, being that Part of Government Lot Three, lying South of the South right-of-way line of the Elgin, Joliet and Eastern Railroad, and more particularly described as follows: 31-38-19

Commencing at the intersection of the North and South, centerline of said Section 32, and the South right-of-way line of the Elgin, Joliet and Eastern Railroad Company, thence north 88° 58' 48" West, along the South right-of-way line of the Elgin, Joliet and Eastern Railroad, a distance of 605.01 feet to the point of beginning; thence North 88° 58' 48" West, along the South right-of-way line of said Elgin, Joliet and Eastern Railroad, a distance of 834.72 feet; thence South 01° 01' 12" West, a distance of 188.42 feet to a point in the Grand Calumet River; thence South 76° 58' 00" East, a distance of 172.0 feet to a point on the Calumet River; thence South 65° 37' 00" East, a distance of 98.92 feet to a point in the Grand Calumet River; thence South 89° 17' 29" East, a distance of 580.33 feet; thence North 00° 00' 10" West, parallel to the North and South centerline of Section 32, a distance of 260.34 feet to the point of beginning, all in the City of East Chicago, Lake County, Indiana, containing 4.780 acres, more or less.

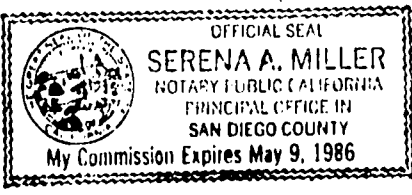
