including all buildings or improvements thereon (or that may hereafter be erected thereon), and the rents, issues and profits thereof, together with all rights, privileges and appurtenances thereto, to secure the payment of \$12,220.00

dollars, as evidenced by a Note of even date herewith; and the mortgagor expressly agrees to pay the sum of money above secured, without relief whatever from valuation or appraisal laws of the State of Indiana; and upon failure to pay said note, or any part thereof, when due, or the interest thereon, or any part thereof, when due, or the taxes or insurance as hereinafter stipulated, then all of said note to be due and collectible, and this mortgage may be foreclosed accordingly. And it is further expressly agreed, that until all of said note is paid, said mortgagor will keep all legal taxes and charges against said premises paid as they become due. Mortgagor shall keep all improvements now or hereafter erected on the property continuously insured against loss or fire or other hazards in an amount not less than the total obligation secured hereby. All policies shall be held by the mortgagee and be in such companies as the mortgagee may approve, and have loss payable first to the mortgagee as his interest may appear and then to the mortgagor, and failing to do so, said mortgagee may pay said taxes or insurance, and the amount so paid, with interest thereon at the rate in the note, shall be a part of the debt secured by this mortgage.

Should the mortgagor or its successor in interest without the consent in writing of the mortgagee sell, transfer, or convey, or permit to be sold, transferred or conveyed, by agreement for sale or in any manner, its interest in the property (or any part thereof), then mortgagee may declare all sums secured hereby immediately due and payable, subject to applicable law. 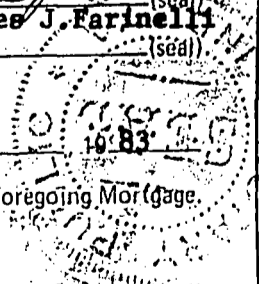
