KNOW ALL MEN BY THESE PRESENTS That we, **Chicago Heights Carrier Electric** of **Chicago Heights, Illinois** (hereinafter called the Principal) as Principal, and THE OHIO CASUALTY INSURANCE COMPANY, an Ohio corporation with principal offices at Hamilton, Ohio, (hereinafter called the Surety) as Surety, are held and firmly bound unto **County of Lake, Indiana** (hereinafter called the Obligee), in the penal sum of **Five Thousand and no/100** (\$ **5,000.00**) Dollars, for the payment of which well and truly to be made we do hereby bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

SIGNED AND SEALED this **1st** day of **January** 19**84**

WHEREAS, the said Principal has made or is about to make application to said Obligee for **a license as Contractor under county unified contractor bonding ordinance**

for a term beginning on **January 1, 1984** * and ending on **December 31, 1984**
 *(Strike out if license or permit is issued for indefinite term)

NOW, THEREFORE, If the Principal shall indemnify the Obligee against any loss directly arising by reason of the failure of said Principal to comply with the laws or ordinances under which such license or permit is granted, or any lawful rules or regulations pertaining thereto, then this obligation shall be void; otherwise to be and remain in full force and effect.

PROVIDED, HOWEVER, AND UPON THE FOLLOWING EXPRESS CONDITIONS:

1. This bond shall be and remain in full force during the term of said license or permit unless cancelled in accordance with paragraph 2 below; but if said license or permit was issued for a term of one year or any other specific term, and said license or permit is renewed for one or more specific terms, this bond shall be and is hereby extended to cover during such additional term or terms. In no event, however, shall the liability of the Surety be cumulative from year to year or from period to period, nor exceed the penal sum written in the first paragraph of this bond.

2. The Surety shall have the right to terminate its liability hereunder by notifying in writing **County Clerk, County of Lake, Indiana**

(Give name and address of department or official to whom notice should be addressed)

ten (10) days in advance of its intention so to do.
