ORDER APPROVING ADMINISTRATOR'S FINAL REPORT  
AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING,

AND CLOSING ESTATE

THIS CAUSE CAME TO BE HEARD on this 5<sup>th</sup> day of NOVEMBER,  
1982, upon the Final Account, Petition to Settle and Allow Account  
and for Authority to Distribute Estate, filed by JAKE W. RUBIN, as  
Co-Administrator of the Estate of MARY FERYO, deceased, which Account  
and Petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereon, and  
the Court being fully advised in the premises, now finds that:

1. Due notices of the filing of said Account and Petition  
and of the Hearing on same, were given to all persons interested  
in said Estate, and the same are now properly before the Court for  
final action thereon.

2. That MARY FERYO died intestate, a resident of Lake County  
of Lake, State of Indiana, on the 15th day of September, 1980, and  
said Administrators were issued Letters of Administration on the  
28th day of September, 1980, and since that date, they have continued  
to serve in such capacity.

3. That the matters and things stated in said Account and  
Petition are true; and that said Administrators have accounted for  
all of the assets in this Estate, coming into their hands.

4. More than five (5) months have elapsed since the date of  
the first published notice to the heirs and creditors of said decedent  
all claims filed against said Estate and all debts and liabilities  
of said decedent and her Estate except those incidental to transfer

and distribution have been paid or discharged; neither said decedent nor her Administrator was an employer within the meaning of that term as used in the Indiana Employment Security Act; all Estate taxes, Inheritance taxes, and Gross Income taxes due the State of Indiana have been paid; together with the Federal Estate taxes.

5. That the decedent died leaving the following heirs at law pursuant to the provisions of Indiana Code, I.C. 29-1-2-1:

and that said decedent died unmarried, leaving no other child or children, nor descendants of any predeceased child or children, other than those enumerated above.

6. That the decedent owned a certain piece of real estate located at 3545 Broadway, Gary, Indiana, more particularly described as follows:

Lake County, Indiana,

and that upon the death of said decedent, said real estate vested by the laws of intestacy to PAULINE ANTHONY, ANN SPRINGMAN, HELEN URBAN, MADLINE PETRIE, MICHAEL FERYO, JR., and MICHAEL FERJO, SR., all being second cousins of said decedent, as tenants in common.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED by the Court, as follows:

1. Said Final Report and Account of said Administrator is hereby in all things approved, settled, and confirmed.

2. That said distribution of the balance of the property remaining in said Administrator's hands for distribution should be made pursuant to the distribution set forth in the Final Accounting and is hereby in all things approved.

3. That pursuant to the laws of intestacy the following described real estate to-wit: *Key #7-65-40*

Lot 37, Block 1, South  
Broadway addition, Gary,  
Lake County, Indiana,

is hereby vested in PAULINE ANTHONY, ANN SPRINGMAN, HELEN URBAN, MADELINE PETRIE, MICHAEL FERYO, JR., and MICHAEL FERJO, SR., as tenants in common.


And that said Administrator is hereby directed to procure and record in the office of the Recorder of Lake County, Indiana, being the county in which said real estate is located, a certified copy of this Final Decree.

4. Said Administrator is hereby directed to distribute and pay over the balance of the estate in his hands for distribution in the amount of \$144,221.20, as follows:

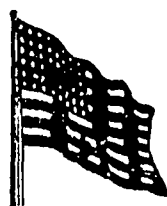

5. Said Administrator is hereby directed to file his Supplemental Report showing that he has complied with the terms of this Order and that said Administrator has in all things carried out the provisions of this Final Decree.
