This matter is now submitted to the Court for hearing on the Executor's Final Report and Accounting, Petitions To Settle and Allow Account and Closing of Estate, which Final Report and Accounting and Petitions are as follows: (Here Insert).

And it appearing that no objections were filed thereto and the Court, having examined and considered the same, now finds that:

1. The required notice of the hearing on said Final Report and Accounting and Petitions was given and the same is now properly before the Court for final action thereon.

2. The decedent herein, FRANK KOZIOLKIEWICZ, died testate on February 17, 1983, domiciled in East Chicago, Lake County, Indiana, and his Last Will and Testament was admitted to probate in this Court on March 4, 1983, and on March 4, 1983, LILLIAN ZATLOKOWICZ was appointed Executor and Letters Testamentary were issued to her.

3. The matters and things stated in the said Final Report and Accounting and Petitions are true and the Executor has accounted for all of the assets of this estate coming into her hands.

4. More than five (5) months had elapsed since the date of the first published notice to the heirs and creditors of the estate; all claims filed against the estate and debts of the decedent have been paid and discharged; neither the decedent nor the Executor were employers of labor within the definition of that term as used in the Indiana Employment Security Act; all federal and state income taxes and Indiana Inheritance Taxes have been paid; and the estate was not subject to the payment of any federal estate tax.

5. All assets of the decedent's estate have been administered upon and all obligations of the Executor have been discharged.

2. The Executor is hereby directed to record a certified copy of this Order and Decree in the Office of the Recorder of Lake County, Indiana.

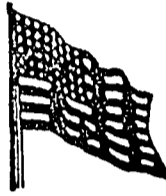
