

Real Estate located in Lake County, State of Indiana, more particularly described as follows, to-wit:

256 acres of farmland and buildings in Sections 10 and 15, Township 32 North, Range 8 West of the 2nd principal meridian, described as follows:

The West 1/2 of Section 10, Township 32 North, Range 8 West of the 2nd Principal Meridian, in Lake County, Indiana, except the following described parcel: Commencing at the Northwest corner of said Section 10; thence South 89°58'03" East along the North line of said Section a distance of 1328.55 feet; thence South 0°08'06" East along the centerline of a drainage ditch a distance of 3343.53 feet; thence South 85°07'19" West along the center line of a drainage ditch a distance of 1344.47 feet to the West line of said Section 10; thence North 0°03'09" East along said West line a distance of 3458.61 feet to the point of beginning.

The Southeast 1/4 of Section 10, Township 32 North, Range 8 West of the 2nd Principal Meridian, excepting that part lying North-erly of the center line of a ditch running in an Easterly and Westerly direction across the South half of the Section, all in Lake County, Indiana.

The Northeast 1/4 of Section 15, Township 32 North, Range 8 West of the 2nd Principal Meridian, in Lake County, Indiana.

Excepting therefrom that part of the Northeast Quarter (NE 1/4) of Section 15 and that part of the fractional Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of Section 10, lying South of the Center line of Brown Ditch, all in Township 32, Range 8 West of the Second Principal Meridian in Lake County, Indiana.
