together with all and singular the tenements, appurtenances, rights, easements and privileges thereunto belonging, as well as the rents, income and profits thereof and therefrom, as well as all heating, air conditioning, plumbing and lighting fixtures and all other equipment and appliances attached thereon, to secure the payment, when the same becomes due of a promissory note of even date, payable to the Mortgagee in the principal sum of 40,000.00, due and payable on or before the .26thav of April 2009 as provided in said note with

interest as provided in said note from date until paid, all without relief from valuation and appraisement laws with reasonable attorney's fees after default.
