upon the final account, petition to settle and allow account and for  
authority to distribute estate filed by Dena Fryman, Executrix of the  
estate of Sharon Fryman, deceased, which account and petition are

And it appearing that no objections were filed thereto and the  
Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition and of  
the hearing on the same were given to all persons interested in said  
estate, and the same are now properly before the Court for final action  
thereon.

2. That Sharon Fryman died testate, a resident of the County of  
Lake, State of Indiana, on the 28th day of September, 1982, and said  
Executrix was issued Letters of Testamentary on the 3rd day of  
November, 1982 and since that date she has continued to serve in such  
capacity.

3. That the matters and things stated in said account and  
petition are true, and that said Executrix has accounted for all the  
assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of  
first published notice, November 11, 1982, to legatees, devisees and  
creditors of said decedent; there were no claims filed against said  
estate and neither decedent nor her Executrix were employers of labor  
within the meaning of that term as used in the Indiana Employment  
Security Act; all estate taxes, inheritance taxes and gross income  
taxes, if any, assessed in said estate have been paid.

5. The following persons are the heirs of the decedent:  
Dena L. Fryman and Sharron K. Fryman and all assets and property of  
this estate remaining after payment of decedent's debts and expenses of  
said administration should be distributed to them as follows: Dena L.  
Fryman, \$75,011.50; Sharron Fryman \$79,180.11; Total of estate being  
\$154,191.61.

6. That the decedent owned a parcel of real estate, more  
particularly described as follows:

Lot 66 in Park Manor Addition to Griffith, as per #26-190-66  
plat thereof, recorded in Plat Book 27, page 92, 000089  
the Office of the Recorder of Lake County, Indiana.


and that said real estate is vested in Dena L. Fryman and Sharron P.  
Fryman, daughters of the decedent.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executrix is hereby in all things approved, settled and confirmed.
2. That the distribution of the balance of the assets remaining in said Executrix's hands for distribution should be made pursuant to the distribution set forth in the final accounting and is hereby in all things approved.
3. That said real estate, more particularly described as follows:  
Lot 66 in Park Manor Addition to Griffith, as per plat thereof, recorded in Plat Book 27, page 92, in the Office of the Recorder of Lake County, Indiana, is hereby vested the name of Dena L. Fryman and Sharron R. Fryman, daughters of the decedent and that said Executrix is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.
4. Said Executrix Dena L. Fryman is hereby directed to distribute the balance of the assets available for final distribution to herself and Sharron R. Fryman as entitled thereto, by the Will of Sharon Fryman in the amount of \$75,011.50 for herself and \$79,180.11 for Sharron R. Fryman and submit a Receipt of Distribution with her Supplemental Report.
5. Said Executrix is hereby directed to file her Supplemental Report showing that she has complied with the terms of this Order and that said Executrix has in all things carried out the provisions of this final decree.
