The west half of lot 5, Moore's addition to the Town of Lowell, as shown in miscellaneous record A page 507, excepting therefrom the following described part thereof, to wit: Commencing at the Northeast corner of the West half of said lot 5 (which point is 148.5 feet East of the North west corner of said lot, which corner is shown on plat survey recorded July 12, 1906 in miscellaneous record 41, page 347, as the intersection of the East line of Clark street and the South line of Michigan Street, and which point is further located as being 181.5 feet East of the West line of the Southeast quarter of Section 23, Township 33 North, Range 9 West of the 2nd P.M.; thence South along East line of the West half of Lot 5 a distance of 90 feet; thence West parallel with North line of said Lot a distance of 35 feet; thence North parallel with the West line of Lot 5 to a point on the North line of the West half of Lot 5 (which is also the South line of Michigan Avenue); thence East along the North line of the West half of Lot 5, a distance of 35 feet to a point of beginning, in the Town of Lowell, Lake County, Indiana.
