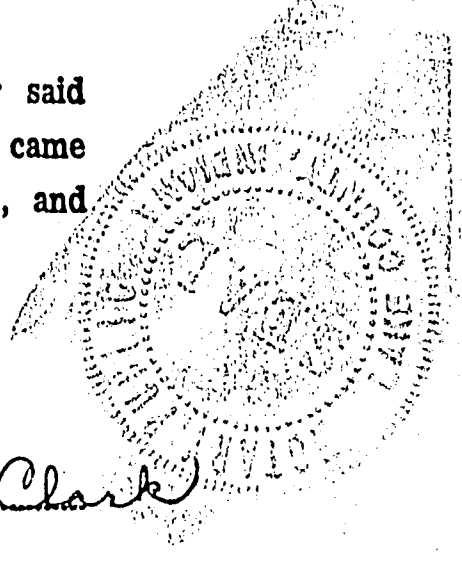

STATEMENT OF LIEN

W. E. Kosiba and T. U. Kosiba

PARCEL I

Part of the southwest quarter of the northwest quarter of the northeast quarter of Section 8, Township 35 north, Range 8 west of the 2nd P.M. in Ross Township, Lake County, Indiana, more particularly described as follows:

Commencing in the northwest corner of the northeast quarter of said Section 8; thence south along the west line of said northeast quarter of said section 667.7 feet; thence east along the north line of the southwest quarter of the northwest quarter of the northeast quarter of said Section 8, a distance of 241.8 feet to the place of beginning; thence east along the last described line 312.45 feet; thence deflecting to the right and southeasterly with an interior angle of 127 degrees, 40 minutes, a distance of 50 feet to a point in the west line of a county road, thence deflecting to the right southwesterly and along the westerly line of said county road with an interior angle of 90 degrees, 220.1 feet to a point; thence deflecting to the right and northwesterly with an interior angle of 130 degrees, .09 minutes, 220.05 feet to a point in the east right of way line of State Rte. 53, now known as State Rte. 55; thence deflecting to the right, northeasterly and along the east right of way line of State Rte. 53, now known as State Rte. 55; with an interior angle of 90 degrees, 37 minutes a distance of 134.58 feet to the place of beginning.

PARCEL II

Commencing at the northwest corner of the northeast quarter of Section 8, Township 35 north, Range 8 west of the 2nd P.M. in Lake County, Indiana; thence south along the west line of said northeast quarter 667.7 feet; thence east along the north line of the southwest quarter of the northwest quarter of the northeast quarter of said section 241.8 feet; thence east along the last described line; 312.45 feet to the point of beginning; thence north 52 degrees, 06 minutes east, 179.41 feet; thence south 37 degrees, 54 minutes east, 50 feet; thence south 52 degrees, 06 minutes west along the northerly line of a county road 179.41 feet; thence north 37 degrees, 54 minutes west, 50 feet to the point of beginning.

PARCEL III

Commencing at the northwest corner of the northeast quarter of Section 8, Township 35 north, Range 8 west of the 2nd P.M. in Lake County, Indiana; thence south along the west line of said northeast quarter 667.7 feet, thence east along the north line of the southwest quarter of the northwest quarter of the northeast quarter of said section, 241.8 feet to the point of beginning; thence east along the last described line 312.45 feet, thence north 52 degrees, 06 minutes east, 159.41 feet; thence north 63 degrees, 15 minutes west, 405 feet more or less to the east line of State Road No. 55; thence southerly along the east line of said highway to the point of beginning.
