FINAL DECREE

This cause came to be heard upon the Final Account and Petition of the Personal Representative of the Estate of the above-named decedent, which account and petition is in the following words and figures, to-wit: (H.I.)

And it appearing that no objections were filed thereto and the Court being fully advised in the premises, now finds that said account and petition and the hearing on same is now properly before the Court; that the matters and things stated in said account and petition are true; and that the Personal Representative has complied with all Federal and State requirements relative to estate administration.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Personal Representative is hereby in all things approved, settled and confirmed;
2. Elm St., Griffith, IN 46319, as tenants in common, each as to an undivided one-twelfth (1/12th) interest; and that said Personal Representative is hereby directed to procure and record in the Office of the Recorder of Lake County, Indiana, a copy of this Final Decree.

4. That said Personal Representative having made distribution of all assets and property and having attached Final Receipts and Waivers evidencing said distribution, said distribution is hereby approved and confirmed;
5. Said Personal Representative is hereby released and discharged from any further liability or responsibility along with her surety with regard to this estate.
6. Said Estate is finally ORDERED closed.
