ORDER

Comes now Plaintiff, in person and by counsel, for hearing on the issue of damages only; matter submitted; evidence heard; and the Court finds as follows:

- 1. That the Plaintiff incurred an expense of Five Hundred Seventy-Seven and 50/100 (\$577.50) Dollars as a result of the Defendant's failure to timely file Plaintiff's bankruptcy petition and by the omission of twelve (12) creditors from the Plaintiff's bankruptcy schedule.
- Thirty-Five and 00/100 (\$235.00) Dollars for attorney's fees and repossession charges to Associates Finance Services due to Defendant's failure to timely file Plaintiff's bankruptcy petition to stay the repossession of Plaintiff's vehicle.
- 3. That Plaintiff paid to the Defendant the sum of Two Hundred Forty and 00/100 (\$240.00) Dollars as and for filing fees to file a complaint against Plaintiff's previous employer, Combustion Engineering, and a stockholder's derivative suit against Combustion Engineering, which suits were never filed.
- 4. That the Plaintiff paid to the Defendant the sum of One Hundred Twenty and 00/100 (\$120.00) Dollars as and for the bank-ruptcy filing fee, when, in fact, only Sixty and 00/100 (\$60.00) Dollars was expended for the filing fee, leaving a balance owed of Sixty and 00/100 (\$60.00) Dollars to the Plaintiff from the Defendant.

- 5. That Plaintiff paid to the Defendant the sum of Two Thousand, Seven Hundred Ninety-Five and 35/100 (\$2,795.35) Dollars as and for attorney's fees of which only One Thousand and 00/100 (\$1,000.00) Dollars worth of work was done, leaving a balance due to Plaintiff from the Defendant of One Thousand, Seven Hundred Ninety-Five and 35/100 (\$1,795.35) Dollars for unearned attorney's fees.
- 6. That Plaintiff Paid to the Defendant trust funds in the sum of Three Thousand, One Hundred Ninety-Five and 46/100 (\$3,195.46) Dollars, of which Three Hundred Seventy-Three and 00/100 (\$373.00) Dollars was paid to Plaintiff's creditors, leaving a balance of Two Thousand, Eight Hundred Twenty-Two and 46/100 (\$2,822.46) Dollars in trust funds unreturned to Plaintiff by the Defendant and converted by the Defendant to his own use and benefit.
- 7. That there is a total owed to Plaintiff from the Defendant excluding accrued interest on the unearned fees and undistributed trust funds of Six Thousand Forty-Nine and 06/100 (\$6,049.06) Dollars.
- 8. That there is interest due Plaintiff from the Defendant on the unearned attorney's fees of Three Hundred Forty-One and 79/100 (\$341.79) Dollars from April 28, 1983 to August 8, 1984.
- 9. That there is interest due Plaintiff from the Defendant on the unreturned trust funds of Five Hundred Five and 77/100 (\$505.77) Dollars.
- 10. That there is a total sum owed by the Defendant to the Plaintiff of Six Thousand, Eight Hundred Ninety-Six and 62/100 (\$6,896.62) Dollars.
- 11. That based upon the actions of the Defendant, Plaintiff is entitled to punitive damages in the sum of Twenty-Five Thousand and 00/100 (\$25,000.00) Dollars.
- IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that the Plaintiff recover from the Defendant, Jeffrey L. Burge, the sum of Six Thousand, Eight Hundred Ninety-Six and 62/100 (\$6,896.62) Dollars for damages together with punitive damages in the sum of

Twenty-Five Thousand and 00/100 (\$25,000.00) Dollars, for a total judgment of Thirty-One Thousand, Eight Hundred Ninety-Six 62/100 (\$31,896.62) Dollars, plus costs.
