tion and taxes have been paid and discharged; neither the decedent nor the Executor are employers of labor within the definition of the Indiana Employment Security Act.

4. The decedent died leaving a Last Will and Testament, copy thereof being attached hereto. The Executor has reported that Bertha Blanche Preble, wife of the decedent predeceased him and that therefore the residuary bequest of all of the assets of the Estate of the decedent as related at ITEM III thereof said Will has lapsed. 
