This cause came to be heard on the 11 day of December, 1984,  
upon the final account, petition to settle and allow account and for  
authority to distribute estate filed by Charles W. Hranach, Executor  
of the estate of Mary Hranach, deceased, which account and petition  
are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the  
Court being fully advised in the premises NOW FINDS that:

1. Due notices of the filing of said account and petition and  
of the hearing on the same were given to all persons interested in  
said estate, and the same are now properly before the Court for  
final action thereon.
2. That Mary Hranach died testate, a resident of The County of  
Lake, State of Indiana, on the 1st day of May, 1984, and her Last Will  
and Testament was duly admitted to probate before this Court on the  
23rd day of May, 1984, and this Court appointed said Charles W. Hranach  
as executor of the Last Will and Testament of the decedent, and said  
executor was issued Letters of Testamentary on the 23rd day of May,  
1984, and since that date he has continued to serve in such capacity.
3. That the matters and things stated in said account and  
petition are true, and that said executor has accounted for all the  
assets in said estate coming into his hands.
4. More than five (5) months have elapsed since the date of  
first published notice to legatees, devisees and creditors of said  
decedent; all claims filed against said estate, if any, have been

paid and discharged; neither said decedent nor his executor were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following person is the sole legatee and devisee under the decedent's Last Will and Testament: CHARLES W. HRANCHAK, and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration have been distributed pursuant to the terms of decedent's Will.

6. That the decedent owned a certain piece of real estate located at 7430 Arkansas, Hammond, Indiana, in the County of Lake, State of Indiana, more particularly described as follows:

2. That the distribution of the balance of the property remaining in said executor's hands for distribution should be made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament, the following described real estate, to-wit:

is hereby vested in Charles W. 4. Said executor having made distribution of all assets and property to the legatee and devisee, said distribution is hereby approved and confirmed.

5. Said executor is hereby released and discharged from any further liability or responsibility as said executor of the estate of Mary Hbranchak, and said estate is ordered closed.
