DECLARATION OF RESTRICTIONS

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto mutually agree as follows:

- Building Restrictions. The Declarant hereby: agrees that no buildings or other above ground improvements will be constructed upon the north 25 feet of the real estate described on Exhibit "A" which runs immediately south of and parallel to existing Reyome Drive from Arbogast Drive in the Normal Town of Griffith, Lake County, Indiana.
- Taxes and Maintenance. The Owner agrees to mow and maintain the existing landscape on the real estate described on Exhibit "A" at its sole cost and expense and to pay to the Declarant within thirty (30) days upon receipt of a bill therefore all real estate taxes assessed or levied against the real estate described on Exhibit "A" up to a maximum of Three Thousand Dollars (\$3,000) per year until such time as said real estate is developed by the Declarant or until the expiration of the tenth year from the date hereof whichever date occurs first.
- 3. To Run with Land. This Declaration shall be deemed a covenant running with the land and to be for the benefit of the This Declaration shall be deemed real estate described in Exhibit "B".
- Binding Effect. This Declaration shall be binding upon and inure to the benefit of the respective successors, assigns, heirs, and legal representatives of the parties hereto.
