CONVEY AND WARRANT

To GERALD SILVERMAN, an undivided 5.50% interest; DORIS SILVERMAN, an undivided 5.50% interest; LAWRENCE APPELSIES, an undivided 5.50% interest; and EDITH L. APPELSIES, an undivided 5.50% interest,

all of Lake County, in the State of Indiana, for the sum of One Dollar and other good and valuable consideration,

in and to the Grantor's remaining 22% of an undivided one-half (1/2) interest in the following described REAL ESTATE in Lake County, in the State of Indiana, to-wit:
