MARSHAL'S DEED

THIS INDENTURE, made this 14th day of January, 1985, between J. Jerome Perkins, as United States Marshal for the Northern District of Indiana, Party of the First Part, and First Family Mortgage Corporation of Florida, of the State of Florida, Party of the Second Part,

WITNESSETH:

WHEREAS, on the 5th day of March, 1984, in a judgment entered by the United States District Court for the Northern District of Indiana, Hammond Division, in a certain cause then pending therein between First Family Mortgage Corporation of Florida vs. Wayne W. Dunn, et al, being Cause No. H83-206, it was ordered that the mortgaged premises described in the complaint in the said action and in the said judgment hereafter described, be sold at public auction pursuant to the laws of this jurisdiction

the order and judgment of said Court, and in conformity with the laws of this jurisdiction governing the sale of mortgaged property under foreclosure, and also in consideration of the premises, and of the said sum of money so bid, as aforesaid, constituting a credit on the indebtedness previously found to be due under the judgment of foreclosure of the above-entitled cause, the receipt whereof is hereby acknowledged, has bargained and sold, and by these presents does grant and convey to said First Family Mortgage Corporation of Florida, the following described real estate located in Lake County, Indiana, to-wit:

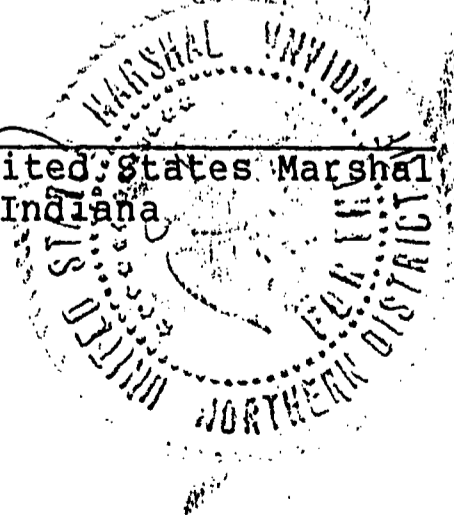


