ORDER AND DECREE

- 1. Comes now the Executor, Frank J. Thomas, by attorney, Kenneth E. Knight, and shows publication of notice of hearing and of final settlement of estate in The Lake County Star on January 24, 1985, returnable February 8, 1985, and proof of such publication is made by the affidavit of Vincent V.
