the clerk of the municipality with whom this bond is filed and to the Principal, addressed to them at the munici-
pality named herein, and at the expiration of thirty (30) days from the mailing of said notice, this bond shall ipso
facto terminate and the Surety shall thereupon be relieved from any liability for any acts or omissions of the
Principal subsequent to said date.

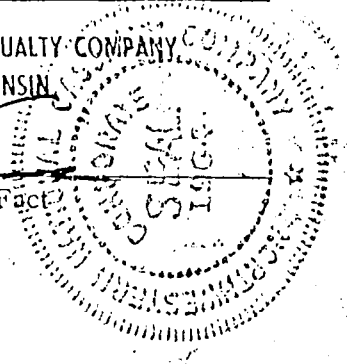
