LOAN MODIFICATION AGREEMENT

WHEREAS,

American Savings & Loan Association,  
an Indiana Corporation

loaned First Bank of Whiting as trustee u/t #1470, the sum of Sixty Two Thousand and no/100 - - Dollars, as evidenced by the note and mortgage executed and delivered on September 5, 1979, which mortgage is duly recorded as Document Number 554779 in the public records in the Jurisdiction where the mortgage property is located, which note and mortgage are hereby incorporated herein as a part of this instrument; and

WHEREAS, the Fogelson Companies, being the beneficial interest holder of said trust, agrees to the terms of this loan modification agreement as herein stated; and

WHEREAS, the parties desire to restate the modified terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, as of the date of this agreement, the unpaid balance of said indebtedness is Sixty Thousand and Ten and 93/100 Dollars.

ALL OF WHICH the undersigned promises to pay with interest at 12.50% per annum, commencing January 1, 1985, until paid, and the same shall be payable Six Hundred Fifty Four and 33/100 Dollars per month begining on the 1st day January, 1985, to be applied to interest and principal with any balance due hereunder, due and payable no later than January 1, 1988, and that in all other respect said mortgage contract shall remain in full force and effect.
