AFFIDAVIT OF HEIRSHIP

Stanley Jasinski, Jr. being just duly sworn upon his deposes and says:

1. That affiant is the grandson of Frank Jasinski who died on March 21, 1927 and Pauline Jasinski who died on March 12, 1972.

2. That prior to their deaths affiant's said grandparents were married and lived together as husband and wife and had six children whose names are as follows: Alex Jasinski, Vera Jasinski Ratajczak, Walter Jasinski, Stanley Jasinski, Anna Jasinski (Chasteler) and Chester Jasinski.

3. That said Anna Jasinski is a married, adult woman who survives her parents and her name pursuant to her marriage is now Anna Chasteler.

4. That affiant is the son of said Stanley Jasinski, who died on January 26, 1981 leaving surviving as his heirs the following persons: Anna Jasinski his widow, Frank Jasinski his son, affiant Stanley Jasinski, Jr. his son and Dorothy Carroll his daughter; that the Estate of Stanley Jasinski #HE81-124 is pending in Lake Superior Court, Room #1, Hammond, Indiana.

5. That said Vera Jasinski died on February 18, 1970 and left as her heirs her husband John Ratajczak, Sr. who died on February 22, 1981 and her adult son John Ratajczak, Jr. who has survived and is Vera (Jasinski) Ratajczak's sole heir.

6. That said Alex Jasinski died on October 13, 1957 unmarried, and without children leaving no surviving heirs.

That said Walter Jasinski died on March 13, 1975 leaving as his heirs his wife Josephine Jasinski who died on October 4, 1977 and his adult daughter, Laura Jasinski, who has survived and is beneficiary of a trust under her mother, Josephine Jasinski's will wherein Eugene Bednarek is named trustee.

8. That said Chester Jasinski is an adult and survives.

9. That real estate described as Lots 10, 11, 14, 15, 16 and 17, Block 4, Marbles Subdivision of Blocks 3, 4, 5 and 6 in Marbles Addition to the City of Hammond was titled in the name of affiant's grandfather said Frank Jasinski but said real estate has been exclusively occupied




