5. The land referred to in this policy is described as follows:

A parcel of land in the Northwest Quarter of Section 8, Township 34 North, Range 8 West of the 2nd P.M., bounded by Clark Street on the North, by Joliet Street on the South, by Court Street on the West and by Main Street on the East, also known as the Lake County Court House, in the City of Crown Point, in Lake County, Indiana, and more particularly described as follows: Commencing at the Northeast corner of the "Court House Lot" as shown on the plat of the original Town of Crown Point, thence South a distance of 61 feet to the point of beginning, this point being the intersection of the West line of Main Street and the South line of Clark Street; thence South 0 degrees 20 minutes 55 minutes West along the West line of Main Street a distance of 306.58 feet to the North line of Joliet Street; thence North 89 degrees 50 minutes 45 seconds West along the North line of Joliet Street a distance of 217.75 feet to the East line of Court Street; thence North 0 degrees 13 minutes 45 seconds East along the East line of Court Street a distance of 306.77 feet to the South line of Clark Street; thence South 89 degrees 47 minutes 15 seconds East along the South line of Clark Street a distance of 218.45 feet to the point of beginning.
