An undivided one-fourth interest in seven (7) shares of Lake County Farm Bureau Co-Op Common Stock to Carol Hartz, Heather Beck, Bruce McNeill and Jean Bernard.

5. Said Executrix is hereby directed to file her Supplemental Report showing that she has complied with the terms of this order
