**ORDER TO REOPEN ESTATE AND
SUPPLEMENTAL DECREE
OF DISTRIBUTION**

This cause came to be heard on the 19 day of April,
1985, upon the Petition for Supplemental Decree of Distribution
filed by Teresa Kenney as Executrix of the Estate of George
J. Schneider, deceased, which said petition is in the following
words and figures, to-wit: (H.I.)

And the Court being duly advised in the premises now
finds that:

1. George J. Schneider died testate a resident of Lake
County, Indiana, on October 25, 1982 and that his Last Will
and Testament was duly admitted to probate in this Court.

2. That the administration of said estate was fully
completed and that the executrix filed her final account
with this court on July 11, 1983.

3. That this court entered an order on August 24, 1983,
approving of said executrix's fulfillment of her duties,
discharging said executrix, and closing the estate.

4. That said order failed to include among its provisions
a decree vesting a certain parcel of real estate owned
by the decedent in the intended devisee pursuant to the
terms of decedent's Last Will and Testament.

5. That the decedent, George J. Schneider, owned at

Estate ordered closed.

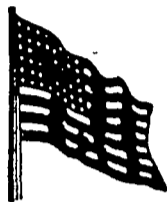
