4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his executor were employers of labor within the meaning of the term as used in the Indiana Employment Security Act; no estate taxes were due; inheritances taxes, Indiana Gross and Federal Income Taxes assessed in said estate have been paid.

Crown Point, Indian 46307. *Key # 23-138-29*


is hereby vested in Wladyslaw Bajgrowicz, pursuant to the provisions of the decedent's Last Will and Testament.
