2. That Anthony Aschenberg died testate, a resident of the County of Lake, State of Indiana, on the 21st day of April, 1981, and his Last Will and Testament was duly admitted to probate before this Court on the 8th day of May, 1981, and this Court appointed said Annette Hodge as executrix of the Last Will and Testament of the decedent, and said executrix was issued Letters of Testamentary on the 12th day of May, 1981, to her and since that date she has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said executrix as accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his executrix was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any assessed in said estate have been paid.

5. The following persons are the sole legatees and devisees under the decedent's Last Will and Testament: Edward M. 1. Said Final Report and Account of said executrix is hereby in all things approved, settled and confirmed.


2. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:
