RELEASE OF EASEMENT

That part of Trankle Court and certain alleys as platted and laid down in Stafford & Trankle's 6th Addition to the City of Hammond, described as follows:

That part of Trankle Court lying south of a line parallel to and 54 ft. north of the north line of Lot 19 in said Stafford & Trankle's 6th Addition.

That part of the 14 ft. alley on the west side of said Stafford & Trankle's 6th Addition lying south of a line parallel to and 54 ft. north of the north line of Lot 19 in said Addition.

That part of the 20 ft. alley lying on the north side of Lot 19 in Stafford & Trankle's Addition between the west line of Trankle Court and the east line of the alley on the west side of aforesaid Addition.

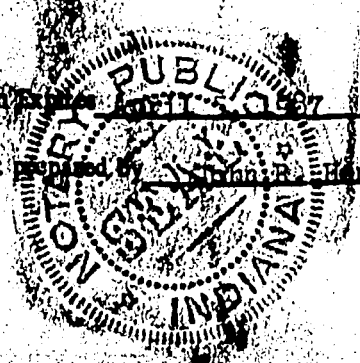
