- 1. Replace tile in kitchen.
- Replace or repair cabinets.
- 3. Exterminate for roaches.
- 4. Water from upstairs bath leaks into lower bath.
- Replace ceiling plaster in bath.
- 6. Replace runner on stairs.

Upstairs

- 7. Finish or carpet all floors.
- 8. Place doors on bedrooms.
- 9. Replace bath floor completely and replace tub.
- 10. Place new plywood on kitchen floor and tile.
- 11. Place cabinets in kitchen.
- 12. Rebuild rear staircase and exterior wall.
- 13. Replace stairs to basement.
- 14. Have NIPSCO check for gas leak.
- 15. Scrap and tuck-point and parage basement common brick walls.
