2. That Ruby Jean Williams, died intestate, a resident of the County of Lake, State of Indiana, on the 13th day of April, 1984, and said Administrator was issued Letters of Administration on the 11th of May, 1984, to him and since that date, he has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true and that said administrator has accounted for all of the assets in this estate coming into his hands.

More than five (5) months have elapsed since the date of the first published notice to the heirs and creditors of said decedent; all claims filed against said estate have been discharged; neither said decedent nor his administrator were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

4. Said administrator is hereby directed to distribute and pay over the balance of the estate in his hands for distribution as follows:

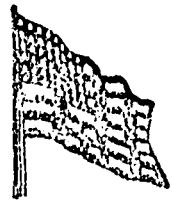
