In order to secure payment of Six Million Eight Hundred Eight-Five Thousand Dollars (\$6,885,000) in aggregate principal amount of City of Hobart Economic Development Revenue Bonds (American Diagnostics Group, Inc. Project) dated as of the date hereof, and Additional Bonds which may be issued pursuant to the Trust Indenture (hereinafter identified), the CITY OF HOBART, INDIANA (the "Issuer"), as mortgagee under and pursuant to a Mortgage and Security Agreement dated as of the date hereof from American Diagnostics Group, Inc., to the Issuer, for value received, does hereby transfer and assign to American Fletcher National Bank and Trust Company, Trustee pursuant to a Trust Indenture, dated as of the date hereof, between the Issuer and the aforesaid Trustee, (a copy of which Trust Indenture is on file at the corporate trust office of the Trustee in (Indianapolis, Indiana, and is available for inspection), all its right, title and interest in, to and under the aforesaid Mortgage and Security Agreement recorded on 10-25, 1985, as Instrument No. 826060 of the Lake County, Indiana Mortgage Records, and in and to the premises described therein.




