ORDER APPROVING EXECUTOR'S FINAL REPORT
AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING,
AND PETITION FOR ORDER APPROVING DISTRIBUTION
AND CLOSING ESTATE

This cause came to be heard on the 12th day of November, 1985, upon the final account, petition to settle, and allow account and for authority to distribute estate filed by ANNE PISKOROWSKI, as Executrix of the estate of JOSEPH F. PISKOROWSKI, deceased, which account and petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That JOSEPH F. PISKOROWSKI, died testate, a resident of the County of Lake, State of Indiana, on September 7, 1984, and his Last Will and Testament was duly admitted to probate before this Court on December 7, 1984, and this Court appointed said ANNE PISKOROWSKI as Executrix of the Last Will and Testament of the decedent, and said Executrix was issued Letters of Testamentary on December 7, 1984, to her, and since that date she has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said Executrix has accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his Executrix was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration have been distributed to the above-named persons, as evidenced by their receipt which is attached hereto and made a part of this accounting.

6. That the decedent owned a certain piece of real estate located at 440 - 139th Street, Lake County, State of Indiana, more particularly described as follows:

and a certain piece of real estate located at 432 - 139th Street, Lake County, State of Indiana, more particularly described as follows:

Block 1, in the City of Hammond, Lake County,
Indiana

and that the decedent devised said real estate in Article III of his Last Will and Testament to ANNE PISKOROWSKI for her life and the remainder interest to THOMAS J. PISKOROWSKI.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executrix is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said Executrix's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:

in the City of Hammond, Lake County, Indiana

Indiana



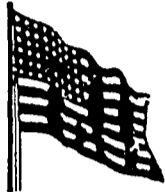
